

## MOTOR SHOW RULES AND REGULATIONS

При получении ответственным лицом просьба информировать всех представителей фирмы

1. Exhibitors are allowed to participate in the exhibition only after timely registration and when making all payments, based on Applications (Forms 1-2). The Organizer provides night protection of the exposition and bears material responsibility for it provided the Exhibitor fulfills the following requirements:
  - Entry of exhibitors to the Motor Show territory is carried out only on the basis of an accreditation issued by the Organizer;
  - for moving-in of exhibits to the exposition, it is necessary to receive a waybill for moving-in / out at the Organizer's stand;
  - driving to the arena of vehicles with a height below than 2.6 m. is allowed only up to the border of the exposition;
  - exhibitors of the Motor Show pass from the central entrance of the JCC to their exhibition stands and check their condition;
  - claims for the safety of exhibits are accepted from the representative of the company at the stand:  
till 9.15 - 11 April; till 9.45 - from 12 to 15 April.
2. Exhibitors are responsible for the safety of their exhibits themselves until the moment the stand is accepted for night security by the service of the **ORGANIZATION COMMITTEE**.
3. Exhibitors of the Motor Show must prepare for the delivery of the exposition for night security according to the Motor Show schedule.
4. Participants of the Motor Show are obliged to fulfill all fire safety requirements and not to use flammable and explosive substances. The use of **helium balls** inside the complex is prohibited, including stands decoration.
5. **Smoking in the territory of PSCC is strictly prohibited!**
6. **Sound accompaniment at the stands of the participants should not exceed 70 DTS.**
7. Any special events/promotion must be agreed with the Organization Committee before **26<sup>th</sup> of March 2018**.
8. Company-exhibitor is liable for giving back her exhibition equipment and agrees to pay three times the value of its lease in case of damage or loss
9. Trade at the exhibition is allowed in accordance with civil code and tax regulations of the Russian Federation. All products must be certified. All products submitted by the participant must comply with the requirements of regulatory documents in force in the territory of the Russian Federation for the quality and safety of products.
10. The Exhibitor is **not allowed** to dismantle and move its exposition until official closing of the exhibition - at **20.00 on 15<sup>th</sup> of April 2018**.
11. **Dismantling of the Motor Show is to be made on 15. 04. 2018 from 20.00 till 24.00 and on 16.04.2018 from 9.00 till 16.00.**
